CLASS REGISTRATION & PAYMENT: Classes are filled on a first-come, first-served basis. A place in the class will not be held until payment has been received, along with signed training agreement and proof of vaccinations from your veterinarian. No refunds will be given after the first day of class in a session has commenced.

SERVICES PROVIDED: Classes are taught and/or coordinated by Elizabeth F. Ford, CPDT-KA and/or Sara H. Bright, CPDT-KA ("Trainer"), certified, professional dog trainer. Class size may be limited so that personal attention may be given to each dog-handler team. Trainer, at his/her discretion, may refuse entry to any dog who is not healthy, is aggressive or does not seem suitable for the services provided.

AGGRESSIVE BEHAVIOR POLICY: In the event that a dog displays aggressive behavior aimed at a person or another dog, Trainer may ask that dog/owner team to leave a class.

VACCINATION POLICY: Proof of vaccines or titer results must be submitted in order to attend class. Adult dogs must have proof of being current on/protected against vaccinations for rabies and the distemper combo. Puppies too young for a rabies vaccination need only provide proof of the distemper combo. If such proof has not been provided prior to class, your dog may not attend.

CLEANLINESS: Owner is responsible for the removal of excrement, urine, vomit, and all other waste for which their pet is responsible.

LIABILITY: Owner agrees to indemnify and hold Best Friends Dog Academy, LLC ("BFDA"), Elizabeth F. Ford, Sara H.
